The Ariel Head of the Patapsco, a three-mile race against the clock, will be held in the southern section of the Baltimore metro area on Saturday, September 25, 2004 on Marley Creek, a scenic, protected body of water. Regatta headquarters will be at the launching area of the Country Club Estates Recreation Association, with ample parking area for rigging boats, picnicking, and watching the races.

Entries and Entry Fees

• Race entries must be received by **Monday**, **September 20**. Entries received past this date will be subjected to a late fee.

The preferred method of registration is through Regatta Central. You may also mail your entries to:

We recognize that there may be a need to make changes after the entry date and the committee will make every effort to accommodate those changes. However, races will not be moved to accommodate hot-seating.

PLEASE NOTE: Entries must be sent in time to be received by September 20, 2004.

• Entry fees are \$15.00 for singles, \$25.00 for doubles, \$45.00 for fours/quads, and \$60.00 for eights.

Checks can be made payable to **Baltimore Rowing Club**

- Late entries must be confirmed by contacting the Regatta Director (see below), and paying a \$10 late fee per entry. No entries will be accepted after 9:00 a.m. on race day.
- The mixed 2X and mixed 8+ events are exempt from the above requirements but must be entered by 12:00 on race day.

Categories/USRA Membership

The Ariel Head of the Patapsco is a USRA registered Regatta. It is now a requirement that all organizations in a registered regatta (with the exception of singles) must be a member of USRowing.

Medals

Medals will be awarded to first place finishers in each category with two or more entries. Categories within a class (for example, Open and Masters within Men's 1X) will be started consecutively, however, awards will be given within each category.

Scratches

All scratches must be emailed or phoned in by September 20, 2004 by 6:00 p.m. EST. The call in number to scratch a boat is (443) 540-4639. We recognize that certain conditions may require a scratch on the day of the race and we will address those during the coaches meeting. Any boat scratched after the September 20th deadline will forfeit their entry fee.

Coaches and Coxswains

• A coaches and coxswains meeting will be held at 8:45 a.m. at the registration table.

- Check in is from 7:00 to 9:00 a.m. when all crews must pick up bow numbers and a number to be pinned to the shirt of the bow-person and coxswain.
- There is no coxswain weigh-in.
- Coxswains of any of the boats (men's or women's) can be of either sex.

Order of Events

Hot seating – a hot topic. While we will do our best to accommodate the "hot-seating" that will invariably occur at any regatta, we will not be rearranging races to allow for the reuse of either athletes or equipment. Teams repeat athletes at their own risk and must be aware of the complications that might result for both the crew and the overall regatta. A minimum of 60 minutes is required between races that involve using the same equipment or coxswain/athlete.

If a boat is late to the line it may be permitted to race down the course at the referee's discretion. If a boat is not at the line when their race is called they will not compete for a medal.

The Course/Rules

The course begins three miles above the launch area on Furnace Creek, proceeding one mile East onto Marley Creek with a hard turn to starboard, and then continues down the eastern side of Marley Creek with the finish line immediately below the launch area.

Boats are walked into the water from a small beach for launching and landing-please bring appropriate shoes and clothing. Crews and coxswains are responsible for being familiar with the course.

Any boat overtaken must move to port or toward the eastern shore of Marley Creek. Penalties will be assessed for missed buoys. All launching shells must have bow balls and foot-release devices. These will be checked prior to launching. No shell will be permitted to launch without a bow ball.

A detailed map of the course will be available at registration and rules will be reviewed at the coaches and coxswains meeting.

Parking

There is limited parking available at the launch site. You may also park in the neighborhood around the Country Club Estates Launching Area. However, be courteous and do not block any private driveways and/or gates.

Restrooms

Portable bathrooms for athletes and spectators will be situated in the launch area.

USRowing WAIVER

AGREE AND WARRANT that I will examine and inspect each Activity in which I take part as a member of the Club and that, if I observe any condition which I consider to be unacceptably hazardous or dangerous, I will notify the proper authority in charge of the Activity and will refuse to take part in the Activity until the condition has bee corrected to my satisfaction.

HEREBY RELEASE, discharge, and covenant not to sue USRowing, the Club, their administrators, directors, agents, officers, volunteers and employees, other participating regatta organizers, any sponsors, advertisers, and if applicable, owners and lessors of premises, on which the Activity takes place, (each considered on of the Releasees herein) from all liability, claims, demands, losses or damages on my account caused or allege to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY< SAVE AND HOLD HARMLESS each of the Releasees, from any litigation's expenses, attorney fees, loss, liability, damage, or cost which any may incur as a result of such claim.</p>

Take Exit 2 and proceed south on Highway 10. Go South on Rt. 10 for approx. 2 miles and then take the exit for Furnace Branch Rd. Turn left at the light at the end of the exit ramp. After 1 mile, turn left onto Country Club Drive and proceed through the residential area. Country Club drive will end at the recreation center/launch area.

From the South

Take I-95 north to the Baltimore Beltway (I-695) then go east toward Glen Burnie. Follow the directions above from Exit 2.
