From Cincinnati

- 1) Take I-71 North through Columbus

From Dayton

- 1) Take I-70 East to I-270 North (on the west side of Columbus)
- 2) Go about 20 miles on I-270, pass I-71, Cleveland Ave exit and Westerville exit
- 3) Take SR 161 East (Exit 30B, "New Albany"))
- 4) Take first exit (Sunbury Rd.)
- 5) Turn Right (north) onto Sunbury Rd.
- **6)** Regatta site will be on your right at Walnut St. (about three miles)

From Parkersburg

- 1) Take I-70 West to I-270 North (on the east side of Columbus)
- 2) Go about 8 miles on I-270 North
