17TH ANNUAL PORTLAND LOOP REGATTA Regatta Information and Schedule

Oregon Rowing Unlimited is pleased to invite you to the 17th Portland LOOP Regatta of Champions on Saturday, November 5th, 2005. The LOOP is a 7-kilometer head race on the Willamette River, from Oswego Pointe to Oaks Park, and is open to juniors, masters, open, and collegiate crews. The events are single sculls, double sculls, fours with coxswain, and eights, for men and women. The regatta features a championship race for collegiate varsity men and women's eights.

Regatta Schedule: Unlike the past few years, the regatta will not be organized by flights. Events will be scheduled to allow continuous launching and landing, which will involve 2-way traffic on the race course.

Please check the web site at http://www.portlandloop.org for schedule and entry seeding. This information is subject to daily change.

The launch schedule will be distributed in the race packets.

NOTE: A crew that arrives late to the start may race out of sequence, but will be given a time penalty of 1 minute.

ENTRIES MUST BE RECEIVED BY MONDAY, OCTOBER 31.

Entry Process: Entries must be received by Monday, October 31. Late entries will be subject to a late fee. Seeding for non-returning crews will be in the order that entries are received. Seeding for returning crews will be based on last years racing results.

NOTE: Registration will be done through Regatta Central (http://www.regattacentral.com). Paper entries will not be accepted. Entry fees may be paid on-line by credit card, or mailed with the waivers to:

Scratch Fees: Scratched entries and no-shows will not be charged an additional fee, however, we do ask that all scratches be made in writing (fax or email) prior to the regatta. Scratches will also be taken verbally at the coaches/coxswains' meeting. Entry fees will be retained by the Portland LOOP for no-shows and scratches. Entry fees will be refunded for events that are cancelled due to lack of entries (minimum of 2 per event for sweep boats, 3 for sculls).

Entry Packets: Contain a bow number, 2 tyvek numbers to be pinned on the coxswain and bow seat, course map, and launching and racing schedules. Packets may be picked up at registration on Friday night at the ORU Boathouse Erg Room from 4:30 – 6:30pm and on Saturday morning at the coaches and coxswains meeting in the ORU Boathouse Erg Room from 5:30am. Entry fees and waivers must be turned in prior to receiving entry packets.

Friday Evening Special Event: There will **NOT** be a LOOP dinner this year at Oaks Park.

Bow Balls and Bow Numbers: Bow numbers will be included in each crew's race packet, along with matching numbers to be worn by the coxswain and bow seat. Bow balls are required, and boats without bow balls will not be allowed onto the racecourse. The regatta committee will not provide these items. Each shell must meet the USRA Rules of Rowing safety standards.

Boat Storage/Trailer Parking: There is a map of Oaks Park on the LOOP web site that shows trailer parking location as well as boat storage locations, bathrooms, boathouse and erg

facilities, and the site of the Coaches and Coxswains meeting. There will be security for boats and trailers in Oaks Park from Thursday night until Sunday night.

Regatta Meeting. The meeting will be held in ORU's Erg Room on Saturday morning at 6:00am. This is a required meeting for all coxswains and single scullers. In addition there must be a coach or other representative from each club or school present. Roll will be taken. Because of the increased hazard of having boats rowing to the start while racing is taking place, this meeting is mandatory. A sculler from each blind boat and every coxswain for each boat will be given a bracelet during roll call, which must be displayed to the dockmaster in order to launch.

Waivers: included in this packet are the individual (under age 18) and team waivers. Although registration is handled online, the waivers must be turned in during registration or completed and mailed to:

Awards: Awards for 1st, 2nd and 3rd places shall be given for each event. In the masters and championship eights events, the LOOP will award an etched glass trophy to the winning men's and women's entries, in addition to 1st place medals.

In addition, 1st place medals will be given to the fastest lightweight single and double scull in each category.

Masters events will not be handicapped; however, 1st place medals will be awarded to the fastest 50+ boat in all masters events where there are 5 or more total entries in that event.

The winner of the Mixed Masters Eight event will receive, in addition to crew medals, the perpetual Mixmaster trophy, which must be returned prior to the next LOOP.

Race Classifications:

"Masters": Boat average age of at least 40 years, and all rowers must be age 21 or older. A competitor's age is determined as of December 31 of the current calendar year. The boat age is determined by the average age of the crew, rounded down. The coxswain's age shall not be counted.

"Juniors": High school or community rowing programs where the oldest rower will not have attained the age of 19 by the end of the calendar year in which the race occurs.

"Open": Any non-collegiate rower or crew not otherwise classified or affiliated.

"Collegiate": Any rower or crew representing a college or university, either as a club or varsity sport.

"Championship": This event, for eights only, is open to all comers, but is intended for collegiate first varsity boats or crews of similar caliber.

Course Hazards and Penalties:

There are 2 bridges, 4 red navigation bouys, and 1 green navigation bouy on the course, as indicated on the course map. Any incidental hazards, such as snags, will be marked with a red balloon or flag. In addition, there are a number of course markers. Crews going outside of the course at any point will be disqualified.

Crews are required to stay to the east of the red bouys, which are located in Milwaukie Bay at about 2 miles into the race (port oars closest to bouys), and to the west of the green bouy, which marks the finish line (starboard oars closest to bouy).

Crews must go through the east span of the railroad bridge, which is at the $\frac{1}{2}$ mile point in the race. Crews MUST NOT go through the east span of the Sellwood Bridge (between the bank and first bridge abutment), and may only go through the span immediately to the right of it (west) The Sellwood bridge is about 500 meters from the finish line.

Crews may be assessed a 30-second penalty for failing to give way, for going through the east span of the Sellwood Bridge, and for passing to the east of the green navigation bouy. Crews passing to the west of the red navigation bouys will be disqualified.

The course will be covered in detail at the mandatory coaches and coxswains meeting.
