I understand that the above activities and the use of all equipment provided for the event at the Pioneer Valley Riverfront Club involve risk of injury to any and all parts of my body. I hereby agree to freely and expressly assume and accept any and all risks of injury or death from the use of this equipment while participating in this activity.

I agree to indemnify and hold harmless the Pioneer Riverfront Club, its owners, employees and agents for any loss or damage, including any that result from claims for personal injury or property damage related to the use of equipment pertaining to biking, running, rowing, Dragon boating, canoeing, kayaking, and stand up paddle boarding at Pioneer Valley Riverfront Club.

I will not modify the rented equipment in any manner including, but not limited to, attaching any human carrying devices to bicycles, such as child carrying device. I will obey all posted signs and trespass laws.

I understand that it is impossible to predict every situation and condition on the water, bike path or road surface the associated equipment will be used on, and that unmarked variations exist on the river and in road and pathway, along with bumps, stumps, rocks, and a variety of other hazards and obstacles. Therefore it is impossible to guarantee the rented bicycles, Dragon boat, row boats, canoes, kayaks and/or stand up paddle boards will perform safely in all situations. I further understand that it is impossible to predict traffic conditions and their risks at the time of my rental of the bicycle.

I realize that it is mandatory that I wear a helmet at all times while bicycling and life vest if under the age of twelve or while using the Dragon boat, kayaks, canoes, rowing equipment and stand up paddle boards. I also realize the helmet and life vest provided with the equipment is necessary safety equipment to help protect against injury, and agree to wear it. I understand there will be a charge for any protective equipment not returned. I understand that these items do not eliminate risk of injury or death to the user.

I therefore agree to **HOLD HARMLESS, RELEASE, DEFEND, AND INDEMNIFY** the Pioneer Valley Riverfront Club, its owners, agents, employees and volunteers from any and all liability for damages and personal injury to myself or any person or property resulting from negligence in selection, adjustment, instruction of use, and/or maintenance of this equipment, accepting myself the full responsibility for any and all resulting damages or injury.
