Race Fees

Registration Fees and Completed Packet must be received by November 1, 2015. Due to site limitations, the local organizing committee has placed a cap on the number of teams and/or the number of boats that can be entered. All entries will be taken on a first-come first-served basis. When your entries are received and accepted, an email will be sent to the contact person listed.

Scratch Policy

Scratches made after the coaches and coxswains meeting should be reported to registration at least one hour prior to the start of the race. A \$25.00 scratch fee will apply to each entry scratched after the meeting. Crews will also be charged \$25 if they are a no show at the starting line.

NCAA Compliance

Colleges should review the event categories with their NCAA Compliance Office to assure collegiate athletes are in compliance with NCAA rules.

Handicapping

Masters handicapping will follow US Rowing guidelines. 10 year age groups will be used for Masters. No adjustments in the decade group.

Multiple Entries

When making entries in an event, a team's fastest boat shall be designated 'A' and so forth.

Alumni Eights

Persons who attended the same academic institution (named at the time of entry application) who are not currently enrolled at the institution in question and have graduated from that high school team (scholastic or club) or college.

Categories

Championship

The top-level (NON JUNIOR) boats may be entered by clubs, colleges or elite programs.

Collegiate Novice

1st year collegiate rowers

Youth

A competitor who does not attain the age of 19 during 2014, or who has been continuously enrolled this academic year in at most a secondary school program, seeking a diploma. No collegiate rowers.

Youth Lightweight

Women: 130 pounds or less Men: 150 pounds or less

Youth < 15

Rowers 14 and under, born after October 12, 1999.

Novice

Rowers with less than one year sculling and/or sweep experience.

Mixed

50% Male and female rowers in the same boat

Open

Any Rower

Alumni

Persons who attended the same academic institution (named at the time of entry application) who are not currently enrolled at the institution in question.

AA Master

21 – 26 years of age. Inclusive as of End of Regatta Calendar Year

Master 1X, 2X, 2-, 4X*

27 – 42 years of age, inclusive, as of End of Regatta Calendar Year

Master 4+ and 8

21 years of age and up, inclusive, as of End of Regatta Calendar Year

Senior Master*

43 – 59 years of age, inclusive, as of End of Regatta Calendar Year

Veteran Master*

60 years of age and above, inclusive, as of End of Regatta Calendar Year

Experienced Coxswains may run novice boats

Check-In

Check in will begin Friday Nov 13, 2015, 3:00pm – 6:30 pm, and continue on Saturday November 14, 2015 beginning at 6:00am. A team coach must check in for the entire team. Masters' Clubs, notify your members of this. (Packets will not be broken up)

Waivers

All Teams must have their athletes or the guardians of their under 18 year old athletes sign the waiver form that is attached to this flyer at the end. Waiver download is also listed on regatta central race website.

Friday Practice

Trailers may not enter the site until 3:00 PM. The site will be available for practice (weather permitting) Friday afternoon starting at 3:00 pm. Only teams that have cleared the registration process will be allowed on the water. Make sure all your forms are in. All boats must be off the water by 6:30 pm. No Exceptions. Teams will be assessed a warning for returning late to the dock. **Each Boat** of a warned team will start the race day Saturday with a warning!

Weigh-In

There is no weigh in for this event.

Coaches, Coxswains, and Scullers Meeting

The Coaches, Coxswains, and Scullers Meeting is set for Saturday, Nov 14 at 7:00 am near the registration tent.

Bow Cards and Back Numbers

Bow cards and Race Bibs for Bow-seat and the Coxswain will be provided. Bow Cards must be returned at the completion of the race. Teams with Lost Bow Cards will be charged a \$10.00 fee. Boats racing without Bow Cards will be disqualified. Tape them on. Race bibs are not required for the Coxswain or Stroke in a Bow-coxed four.

Seeding

Seeding of Races will be at the discretion of the LOC. Factors to be considered include, but are not limited to, last year's finish in the Rowing Rendezvous and the 2015 spring regattas including the national, regional, state, and local races. All "A" entries will proceed "B" entries and so on. There will be no rearrangement of teams in an event for coaches' preference or need, including hot seating.

Awards

Team awards are being given at this regatta. Team awards will be given **ONLY** to first place. Team awards are designed to instill team pride and history and are appropriate for display at your boathouse. Only coaches may sign for and pick up team awards.

Trailer Parking / Boat Storage

Parking for trailers will be designated upon arrival.

Please plan on arriving after 3:00 pm Friday. **No trailers or vehicles may enter the site until after 3:00 pm Friday.** Please plan your travels accordingly. Trailers will be placed in the site on a first come – first serve basis. After parking the trailer, tow vehicles may unhook and move to the adjacent parking lot. All stored boats including car-topped boats, is at your own risk.

Team Tents

Team tents are permitted on the grassy area to the north of the launching area ONLY. The area directly in front of the docks and water will be kept clear for spectators. The tent area is limited to a first come – first served basis. No team or parent vehicles or food trailers will be allowed to enter the tent area. All supplies must be carried in. Food Trailers will be required to park in the spectator / bus parking lot. Volunteers will be onsite Friday and Saturday to help direct tent placements. The Local Organizing Committee has the final authority to have tent moved or removed.

Spectator Vehicle Parking

Directions to the site are available on the website. NON boat hauling vehicles will be directed to the large grass private lot. Location for GPS is 1889 Hontoon Road. This is Past the entry for Trailers. NO CARS will be allowed on Alhambra or Flowing Well Road. Please proceed to the Parking Entrance for directions. The walk from the Parking Lot to Stetson is less than 100 Meters. Boy Scout Troop 550 will be directing parking and asking for a \$5 per car donation. Thank you for your support.

Bus Drop-Off

All Buses should drive down Alhambra and turn left onto Lakeside to unload passengers and then continue moving down Lakeside and return to Hontoon Road. We are sorry not to be able to offer onsite bus parking. That is in the plans for future development on the site. Please have your drivers be on-call for your team pick-up at the end of the day. Thank you for understanding.

Merchandise Sales

Stetson University will be selling the Official Race T-shirt for \$10. Any team wishing to pre-purchase shirts for their members are encouraged to send an email to jbwilson@stetson.edu with the list of sizes and team name. These shirts will be packaged ready for pick up at registration.

Sales of merchandise will be permitted only by advanced arrangement with the Stetson University Rowing. For your merchandise to be sold you must contact Mark Wilson at mrwilson@stetson.edu for requirements, forms, and fees. You must also meet any Local, State, or Federal requirements. See those entities for details.

Cancellation Policy

If, in the opinion of the race management, weather or other unforeseen events cause the racecourse or venue to become unfit or unsafe, the regatta or specific races / events will be cancelled. No refunds will be given.

2015 Hatter Fall Rowing Rendezvous - Regatta Rules

5K Course

This course is relatively simple 5k course with the start 5k from the finish line. The race starts at Navigational Aid #67 on the St. Johns River, runs down stream to Lake Beresford then follows a series of large NO WAKE buoys to the finish line. A wild shoreline covers most of the river course; upon entering the lake some boat traffic may be encountered. All traffic will pass Port to Port and maintain ALL navigation rules of the road. A Course map defining traffic flow will be available at Registration and on the website.

750m Sprint

The 750M Sprint will start 750m to the south of the launching area and finish just off the rowing and launching site. Spectators will be able to see full finish and most of the race.

LOOP Row Course – New for 2015 – Full ½ Marathon 13.1 Miles

The loop row will begin off the dock at Stetson then travel south to the mouth of the St. Johns river and turn right towards Hontoon Marina in the St Johns River to the 55 Chanel Marker and will follow the Dead River through wild sections of the river. NO viewing is available and NO shore improvements are available along the first 13k of the race. Only Experienced rowers should attempt this event. This is NOT intended for novice crews of any kind. ONLY limited support will be available and coxswains and scullers MUST carry water and other supplies as deemed needed. Rowers will travel through a very narrow canal, this area is NO PASSING and you MUST proceed with caution. NO racing or hard strokes should be attempted in canal. Race organizers are NOT responsible for damage of any kind. Once out of the canal, racers will go downstream on the St. Johns and return to the lake for the finish line near the boathouse site. Please plan on 90 -120 minutes of mostly continuous rowing to complete this event.

Call of Events

All times are subject to change. Final times will be distributed to registered teams and posted at the Regatta Headquarters.

Events will be called 45minutes prior to the start of the race. It is the responsibility of the crew to be at the marshaling area prior to the published start time. A crew that misses its correct order at the start may be penalized 10 seconds. A crew that arrives at the start after their event has run shall row exhibition only, or be excluded from the race at the starter's discretion.

Changes to Events

Stay alert to the possibility of schedule changes. The regatta committee reserves the right to combine or cancel events based on the number of entries received, or changes in weather conditions. The committee also reserves the right to delay or advance the starting times for any event.

Hot Seating

Allow a minimum of 45minutes for hot seating rowers or equipment. Plan accordingly. Crews late to the start may be penalized or disqualified.

Dock Area

The Dock Master has absolute authority in the dock area. Please be respectful to launching crews. Failure to follow instructions will result in assessed time penalties. Crews will launch from the south dock (outside marina) and land on the north dock (inside marina) All boats will be inspected prior to launching. Inspection will include bow balls, bow cards, and shoe heel tie downs. We will be following Rules of Rowing for the length of tie downs. A boat that is entered in multiple events will be inspected each time it is launched.

Equipment Adjustments

All equipment adjustments must be made in the staging area prior to launching.

Team Launch/Land Support

No oars are to be staged in the launch area or left in the landing area. Coaches and team members must support the launching and landing of each team boat.

Launching

Launching occurs at the race course Finish. There is NO crossing of rowing traffic on this course. FOLLOW Right Hand Rule at all times. Failure to follow the instructions will result in a time penalty of 60 seconds.

Course Markers

Colored buoys, flags, natural shoreline mark the course. This course is marked in the MIDDLE for most of the course. Only ONE corner has an inside buoy. Please see course map and realize that the racing lane on the lake to the finish line is marked by flags attached to large no wake buoys. There is NO outside lane marker on the lake. Crews should attempt to row from buoy to buoy, any boats rowing wide into the lake will simply be adding distance to their course. Cutting or missing any buoys will result in an assessed time penalty of 30 seconds.

Penalties

Race Organizers wish to instill a competitive, fair and fun atmosphere at the Rowing Rendezvous. Unsportsmanlike conduct of any kind will not be tolerated and any member of a crew displaying such behavior will be given a 5 minute penalty. This rule applies to coaches, parents and fans as well. Missing a buoy, late to the start, passing recklessly, NOT giving way are all 30 second penalties. Failure to follow the launching, warm-up, racing or cool down traffic pattern will result in a 60 second penalty.

Starting Line

There is a counter clockwise circle pattern in the warm-up area. The crews will row past the starting line cross the river and arrange themselves in race order. The Starter / Marshall will arrange the crews so that crews cross the starting line at approximately 10 second intervals. Crews should remain near the Start Marshall to hear commands to the start line. A crew must yield to another crew being summoned to the starting area. A crew that misses its correct order at the start may be penalized 10 seconds. A crew that arrives at the start after their event has run shall row exhibition only, or be excluded from the race at the starter's discretion.

Right of Way

A crew is deemed to be overtaking another crew when it has moved to within one length of open water of the crew ahead. On those portions of the course that are straight, a crew being overtaken shall move to the right and allow the overtaking crew to pass. Where the course turns, a crew being overtaken shall move to the outside of the turn and allow the overtaking crew to pass along the shorter path. Nevertheless, passing is not allowed, nor is the crew being overtaken required to yield, in cases where the overtaking crew's position clearly prevents safe passage or where there is insufficient room to yield. In the event a crew does not yield, a 30 second penalty will be assessed.

Passing

Passing is allowed along the entire course. Only safe and appropriate boat handling will be accepted.

Return

Quickly clear the finish line, You may row out to the end of the lake, once finished with your cool down turn ONLY to the left and follow the shore back to the dock area. Returning crews will launch inside the marina. Use caution and move slowly in and around dock area. Poles are visible and should be avoided.

Protests

Protests for a race must be filed on water at the finish line with an official. You will have one hour from the end of your race to file the written protest with regatta headquarters (near registration) and pay the required \$25 fee (cash only).

I understand and acknowledge that these risks may result in personal injury, including but not limited to the following: collision with other players, sports equipment, & structures; slips/trips/falls; fractures/broken bones; sprains/strains; bruises; lacerations; punctures; concussion; loss of consciousness; drowning; exhaustion; eye injuries; spinal injuries; paralysis; brain damage; serious injury to all internal organs, bones, ligaments, joints, muscles, tendons, and other aspects of the muscular skeletal system; neck, face and head injuries; heart attack; sickness; and/or death as a result of the nature of Sports and related activities. 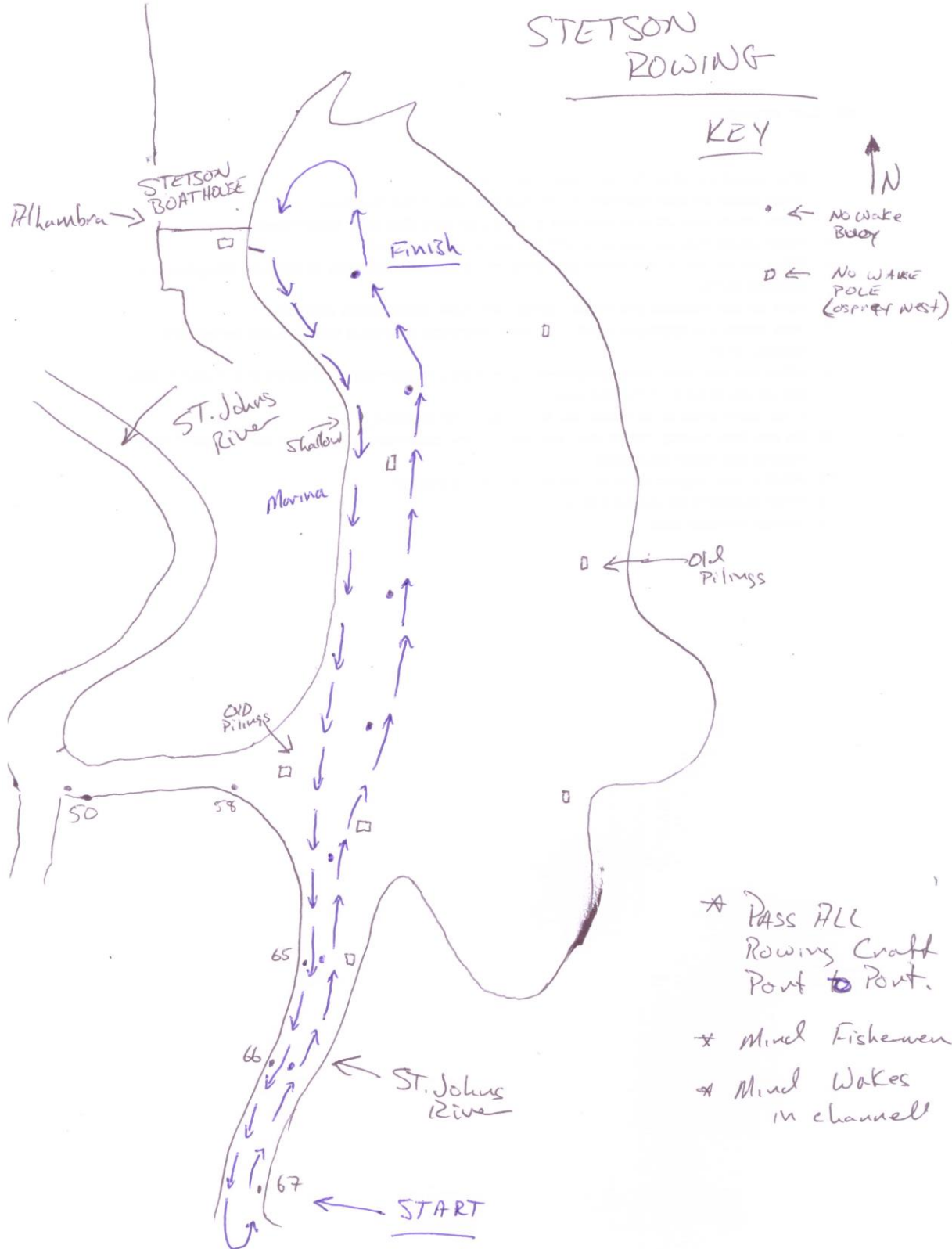

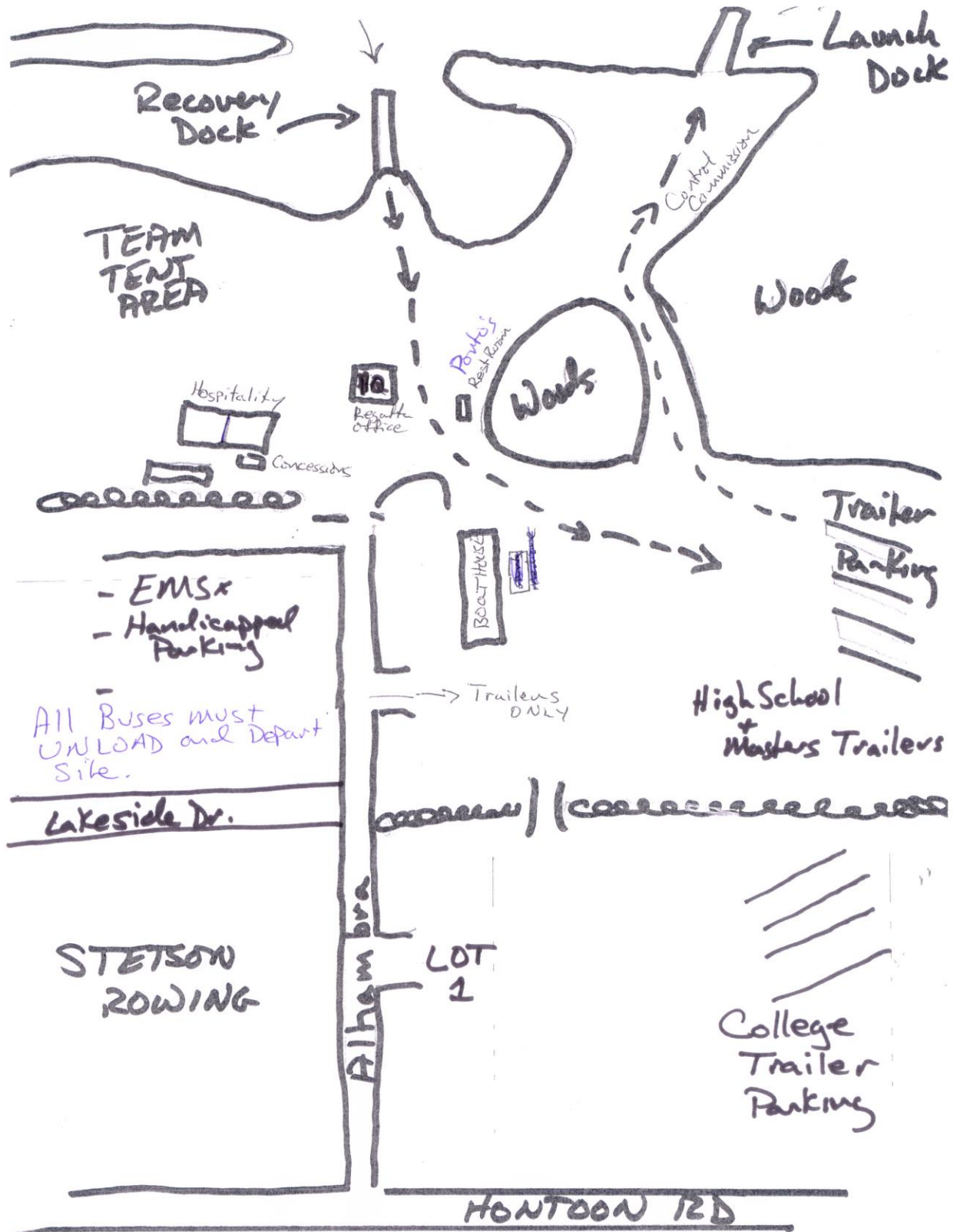
5k course – Launch from outside Dock, warm up to starting line staying to shore. Race on right of all buoys and buoys with flags. Finish at Before Stetson

Stetson University Rowing Event Parking and Traffic Plan

November 8-9, 2014

Traffic and Parking for the Rowing Event at Lake Beresford to be operated off the Stetson University site located at 2636 Alhambra Ave is described below and the attached map will help with descriptions.

-All Traffic will approach the site off Old New York and Hontoon Road. Rowing Trailers will be arriving on Friday afternoon (not before 3pm) and on Saturday Morning.

-All Rowing trailers will be parked on the Stetson University property with approach on Alhambra Ave.

-All Team Support Trailers will approach the End of Alhambra, park and unload on Stetson Property and then move vehicles to spectator parking for the event.

-All Team Buses will unload on Alhambra and exit the area via Lakeside to a remote parking lot off of the peninsula. Buses will be unloading only.

-All Spectator parking will be done on Private Property (1889 Hontoon Road) with the access to that property off of Hontoon Road. Spectators will walk from the Northern edge of the Zimmer property and then walk to the Stetson Property via two vacant lots on Flowing Well. Total Distance to Stetson property is about 100m. The Boy Scouts of America Troop 550 will be asking for a \$5 per car parking donation. Please have cash handy.

-A spectator walking corridor will be clearly marked and prior approval has been granted by the landowners at 2668 Flowing Well and 2671 Flowing Well.

-Signage and parking attendants as well as published directions to all teams will be distributed to proper areas. Signage of the temporary crosswalk at Flowing Well will be posted and notice to all property owners will be mailed and posted in advance of the event.

-Handicapped parking at 1652 Kahlua Way will be marked and supervised. This will also be the parking site for the medical staff. This property is owned by Stetson University.

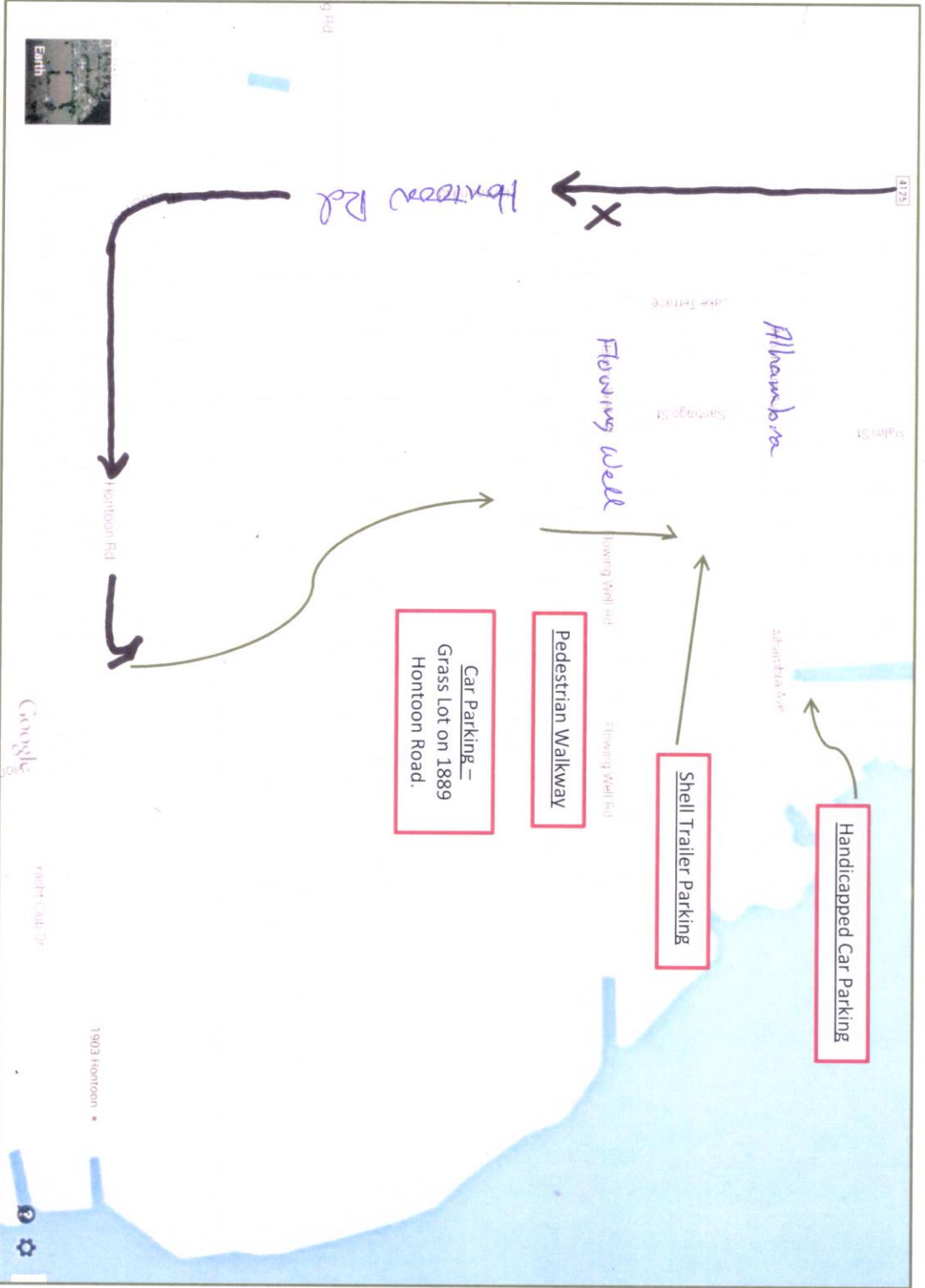
-No parking signs will be posted along Alhambra, Flowing Well, Hontoon, Lakeside, Santiago and Palm Streets.
