

# Hoover Invitational Regatta

Hoover Reservoir, Westerville, Ohio

Saturday, April 16, 2005

Hosted by Westerville Crew

## COURSE

- The racecourse is a 2000-meter course on Hoover Reservoir in Westerville, Ohio, home to the Westerville Crew. The race format is heats followed by finals.
- Hoover Reservoir is a seven-mile, man-made reservoir and the main water supply for Columbus. There is no current on Hoover Reservoir and no advantage of one lane over another. The start area is well protected from the predominant northwest wind by a large bluff. The course has buoys marking its edges and center.
- This is a US Rowing Sanctioned Event and will be run in accordance with the standard rules of racing. Head Referee is Roger Bailey.

➤ Please respect this deadline; your cooperation helps tremendously. Please send your waivers with your entry. All entries must have the appropriate fee included.

➤ Medals will be awarded to 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> place in each event.

➤ Racing is open to Youth & Scholastic HS programs

➤ Hot-seating rowers or equipment requires 50 minute separation.

➤ Please practice with your coxswains and crews the techniques of doing a racing start -- ie, having two scull with bow's oar or three scull with two's.

➤ Coxswains (strokes of bow-coxed boats) must also know that they need to have their hands in the air while they are adjusting their point at the start

➤ DEFINITIONS:

- Novice: Any rower who began competing after spring season 2004.
- Lightweight: Men 155 lbs Women 130 lbs
- Varsity: Any rower eligible as a high school athlete
- Second Varsity: Any rower not in the first varsity boat. In order to have a second varsity entry, a team must first enter a varsity event, except by arrangement for **beginning programs**.

➤ PARKING:

- PLEASE notify regatta director if you are transporting rowers by bus so that appropriate arrangements for unloading and parking can be made.
- PLEASE do not park on the grass *anywhere for any reason*.

## **Directions**

### **From Toledo**

- 1) Take Route 23 South from Toledo to I-270 East
- 2) Take I-270 East to Exit 30B (SR 161 East, "New Albany" Exit)
- 3) Take SR 161 East to first exit (Sunbury Rd.)
- 4) Turn Right (north) onto Sunbury Rd.
- 5) Regatta site is on your right at Walnut Street (about five miles)

### **From Cincinnati**

- 1) Take I-71 North through Columbus
- 2) Take I-270 East to Exit 30B (SR 161 East "New Albany" Exit)
- 3) Take SR 161 East to the first exit (Sunbury Rd.)
- 4) Turn Right (north) onto Sunbury Rd.
- 5) Regatta site will be on your right at Walnut St. (about five miles)

*There are several other good routes through and around Columbus.*

### **From Cleveland**

- 1) Take I-71 South from Cleveland
- 2) Take I-270 East to Exit 30B (SR 161 East, "New Albany" Exit)
- 3) Take SR 161 East to the first exit (Sunbury Rd.)
- 4) Turn Right (north) onto Sunbury Rd.
- 5) Regatta site will be on your right at Walnut St. (about five miles)

### **From Dayton**

- 1) Take I-70 East to I-270 North (on the west side of Columbus)
- 2) Go about 20 miles on I-270, pass I-71, Cleveland Ave exit and Westerville exit
- 3) Take SR 161 East (Exit 30B, "New Albany")
- 4) Take first exit (Sunbury Rd.)
- 5) Turn Right (north) onto Sunbury Rd.
- 6) Regatta site will be on your right at Walnut St. (about five miles)

### **From Parkersburg**

- 1) Take I-70 West to I-270 North (on the east side of Columbus)
- 2) Go about 8 miles on I-270 North  
The freeway will split as you near the Easton Exit. Bear right, following the signs for SR 161 East "New Albany" (Exit 30B)
- 3) Take SR161 East to the first exit (Sunbury Road)
- 4) Turn Right (north) onto Sunbury Rd.
- 5) The regatta site will be on your right at Walnut St. (about 5 miles)

### **From Pittsburgh**

- 1) Take I-70 West to I-270 North (on the east side of Columbus)
- 2) Go about 8 miles on I-270 North  
The freeway will split as you near the Easton Exit. Bear right, following the signs for SR 161 East "New Albany" (Exit 30B)
- 3) Take SR161 East to the first exit (Sunbury Road)
- 4) Turn Right (north) onto Sunbury Rd.
- 5) The regatta site will be on your right at Walnut St. (about 5 miles)

- **Trailers: Go to Walnut Street stop light and turn right into the parking lot**
- **Passenger Cars: Look for regatta parking signs**

IN CONSIDERATION of being given the opportunity to participate in the **Hoover Invitational** ("Regatta") I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of rowing activities, both on the water and land based and that I am qualified, in good health, and in proper physical condition to participate in such Regatta.
2. FULLY UNDERSTAND that:
  - (a) ROWING ACTIVITIES INVOLVE RISKS AND DANGERS of serious bodily injury, including permanent disability, paralysis, and death ("risks");
  - (b) these risks may be caused by my own actions, or inactions, the actions of others participating in the Regatta, the condition in which the Regatta takes place, or the negligence of the "releasees" named below;
  - (c) there may be other risks and social and economic losses either not known to me or not foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the Regatta.
3. AGREE AND WARRANT that I will examine and inspect each Regatta in which I take part and that, if I observe any condition which I consider to be unacceptably hazardous or dangerous, I will notify the proper authority in charge of the Regatta and will refuse to take part in the Regatta until the condition has been corrected to my satisfaction.
4. HEREBY RELEASE, discharge, and covenant not to sue USRowing, the Regatta, their administrators, directors, agents, officers, volunteers and employees, and other participants, regatta organizers, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Regatta take (each considered one of the releasees herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS each of the releasees from any litigation expenses, attorney fees, loss liability, damage, or cost which may incur as a the result of such a claim.

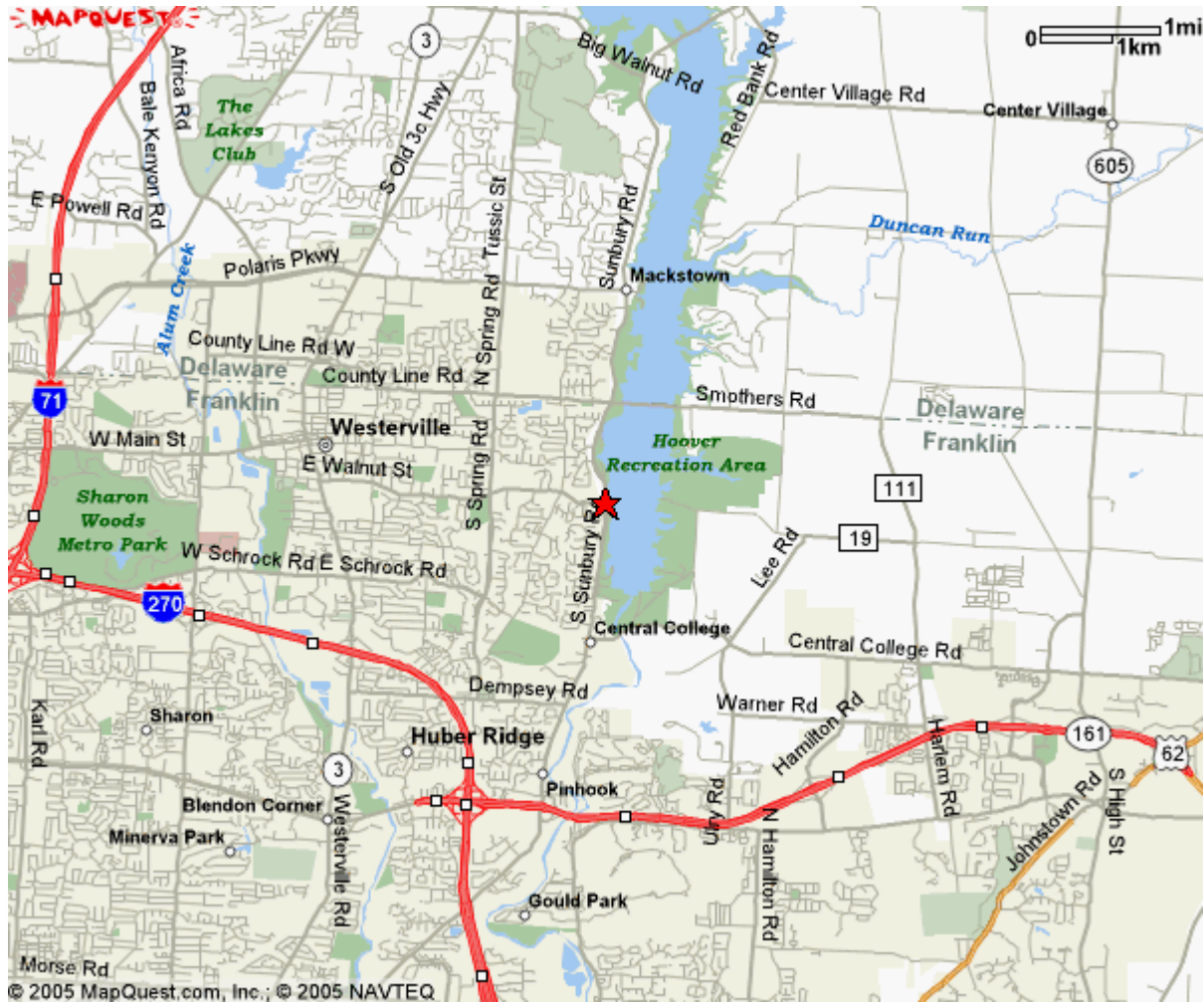
